

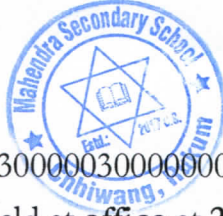



5. **Sealed or electronic** bids must be submitted to the **above office** by **hand/courier** or through PPMO website www.bolpatra.gov.np On **or before** 12:00 O'clock on **2080.09.29 B.S. (2024.01.14 A.D.)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 O'clock on **2080.09.29 B.S. (2024.01.14 A.D.)** at the **above office**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs. 2,93,000.00**, which shall be valid for **30 days** beyond the validity period of the bid **2081.02.01 B.S. (2024.05.14 A.D.)**.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
